PAYMENTS/FORMS: Final payment and all forms that require a signature are due **June 1st**.

CANCELLATION POLICY: A refund (minus a \$50 non-refundable deposit) will be given on cancellations received before May 15th. After that date, no refunds will be provided. There are also no refunds if a child misses camp. There is a \$30 processing fee for changing camp session dates after registration is submitted.

PICK-UP: I understand that I am to pick up my child by 4:00 PM (or by 5:30 PM if my child is registered for After Care.) Should my child need to leave for camp early for personal, health or behavior reasons, I understand there will be no refund for missed activities. I understand the camp cannot release my child to anyone other than a parent or legal guardian without my signed consent. Should I desire someone other than a parent or legal guardian to pick up my child from camp, I will fill out a Transportation Form for the camp to have on file. All Transportation Forms should be submitted prior to the first day of camp.

BEHAVIOR EXPECTATIONS: *I understand and agree with the camp policy on appropriate behavior as stated:* Our experienced staff will provide clear expectations for behavior to ensure a safe and fun experience for all campers. Should a camper have difficulty following certain guidelines, we will follow a 3 warning system where the 3rd warning results in a phone call home. If a second call is necessary in the same day, we will ask that you come and pick your child up from camp immediately. Should your child be sent home twice during the same week, we will ask that he or she not return to camp for the remainder of the week. No refunds will be given for days missed due to behavior. Our staff is committed to working with parents to provide campers the support they need to meet our behavior expectations. Behaviors which may result in an immediate dismissal from camp, without warning, include any behaviors that place the child, campers or staff in emotional or physical danger.

ABILITY TO ENGAGE IN CAMP ACTIVITIES AND ASSUMPTIONS OR RISK: Stonewall Farm takes all possible precautions to reduce risk and provide a safe, healthy and enjoyable experience for all campers. Activities at camp may include, but are not limited to, farm chores, working with animals, running games and being outside. I acknowledge that despite staff efforts, some risk from participation in camp activities still exists and I am allowing my child to attend camp knowing these risks and their possible consequences including personal injury. *Please call if you have any concerns about the activities your child may engage in while on our premises.* **RESTRICTIONS TO ACTIVITY:** _____

WAIVER AND RELEASE OF LIABILITY: As a parent/guardian of this child, I agree that I will not hold Stonewall Farm, its employees, officers or directors liable for any personal injury, property damage or loss. These terms serve as a release for myself and members of my family.

HEALTH & MEDICATION: Prescription and non-prescription medications or drugs of any kind, including asthma medication that my child is bringing to camp are listed on the Health Form. I hereby authorize the camp staff to administer first aid, as well as to dispense medications brought to camp by my child according to directions. I understand that camp activities often include contact with various animals, both cultivated and wild plants, and food items and have listed any known allergies on my child's health form. **RESTRICTIONS TO CARE:** _____
